REGULAR COUNCIL MEETING WITH PUBLIC HEARING MINUTES

A special meeting of the Sabula City Council was held March 24, 2020. In order to help stop the spread of the COVID-19 virus, this special meeting of the Sabula City Council was held electronically. Chapter 21.8 of the Iowa Code does permit an electronic meeting where all members participate remotely when an in-person meeting is impossible or impractical, which is certainly true during this crisis. On March 19, 2020 Governor Reynolds issued a Proclamation of Disaster Emergency which included a suspension of Iowa laws that would prevent the use of electronic meetings or the limitation on the number of people present at an in-person meeting site. Therefore, only Mayor Hansen and Council members Kramer and Ward were present at Sabula city hall at 411 Broad Street. The agenda and the City's social media had this message posted 24 hours in advance to give instructions on how others could participate in the meeting: Due to the COVID-19 Pandemic this meeting will not be open to the public. Mayor Hansen called the meeting to order at 6:38 p.m.

Public Hearing

D. Ward made a motion: seconded by P. Meyers to open public hearing. All ayes. Motion carried.

Solicitation of comments for the Adoption of Budget and Certification of City Taxes for FY20/21. No comments were received in the office. Council member H. Kramer did question the clerk 4 days prior to the meeting if budget meetings were planned. The clerk informed him that she worked with the department heads, deputy clerk and the Mayor to complete the budget. She stated that this is how it has been done for the last 3-4 years.

Motion carried. This states that if the city would receive funds in the amount of \$25,000, they would have to provide funding in the amount of \$5,000.00

Donation to Jackson Co. Historical Society

Rich Epich informed the council that he is on the Historical Society Board. They were given approximately 40 portraits from City Hall that had been damaged by mold and mildew to restore. The pictures were from the Sabula School. He stated that the backing material on the pictures had been damaged and that they had begun to restore them. Once they are restored they will be photographed and cataloged. They will then be displayed at the Historical Society. The JCHS will also be putting them on a CD to give to City Hall. He asked that Council consider a donation to the Historical Society to help with the costs. H. Kramer made a motion to donate \$100 to the JCHS to help with the costs; seconded by D. Ward. All ayes. Motion carried.
