REGULAR COUNCIL MEETING MINUTES

A Regular Council Meeting was held on Tuesday, July 28, 2020 at 6:30 p.m.

In order to help stop the spread of the COVID-19 virus, this regular meeting of the Sabula City Council was held electronically. Chapter 21.8 of the Iowa Code does permit an electronic meeting where all members participate remotely when an in-person meeting is impossible or impractical, which is certainly true during this crisis. The agenda and the City's social media had this message posted 24 hours in advance to give instructions on how others could participate in the meeting.

Mayor Pro Tem Franzen called the meeting to order at 6:30 p.m.

Regular Council Meeting

D. Ward made a motion to open the council meeting; seconded by P. Meyers. All ayes. Motion carried.

Visitors with business- David Heiar was present to answer any questions related to the Catalyst Grant agenda items.

Deletions- Agenda items #8 and #17.

Citizen Concerns – The City Clerk informed Council and Mayor Pro Tem Franzen that 2 complaints had been received. The complaints had not been addressed by the Mayor at the time of the meeting. Once they are addressed they will be passed on to Chief McPherson.

Agreement with Iowa Economic Development Authority

P. Meyers made a motion to direct the Mayor to sign the agreement with the Iowa Economic Development Authority Iowa Downtown Resource Center Community Catalyst & Remediation Grant Program; seconded by R. Epich. All ayes. Motion carried. Total estimated cost of the project is \$509,276. The City's financial contribution is \$40,000 and other contributions equal \$116,246. The financial pledge from the owner is \$253,030. The City is requesting \$100,000 in Catalyst funds.

City Match for Catalyst Grant

Motion made by R. Epich; seconded by P. Meyers to take the \$40,000 out of Economic Development and at the same time start working on establishing a TIF district. All ayes. Motion carried.

Resolution #1210, Setting a Public Hearing Date

Motion made by R. Epich; seconded by P. Meyers to approve Resolution #1210, Setting a Public Hearing Date for the City of Sabula, Iowa Code of Ordinances for August 25, 2020. All ayes. Motion carried. This will be to recodify the ordinances.
